

DERBY AND DERBYSHIRE LOCAL MEDICAL COMMITTEE (DDLMC) DATA PRIVACY NOTICE UNDER THE GENERAL DATA PROTECTION REGULATION (GDPR)

Under the current Act, NHS England and Derby & Derbyshire Integrated Care Board (DDICB) are required to consult the LMC on a wide range of topics affecting GPs' contracts. DDLMC represents the views of the Derbyshire GPs to the wider NHS, other public bodies, the media, and the public. We try to make known your concerns and opinions nationally through the General Practitioner Committee (GPC). We also develop policies on matters concerning general practice that enable GPs in the county to act together. We represent GPs and can assist in pastoral & support work.

2. Data Protection Officer	By virtue of our size, the data we hold and the processing we undertake we are not required to have a Data Protection Officer.
3. Purpose of data sharing	Derby and Derbyshire Local Medical Committee provides advice and support to GPs and practice managers in Derbyshire. We are the local representative body for all GPs providing NHS primary medical services in Derbyshire recognised in statute. In addition to our statutory and representative functions the LMC provides advice, support and guidance to all its represented GPs and practice staff across the whole range of issues affecting GPs and practices. We may also represent other non-NHS contract holding GPs
4. Lawful basis for sharing purposes	<p>The legal basis for our processing is usually Article 6(1)(c) or in specific individual cases Article 6(1)(a):</p> <p>Article 6(1)(c) processing is necessary for compliance with a legal obligation to which the controller is subject. (a) Article 6(1)(a) the data subject has given consent to the processing of his or her personal data for one or more specific purposes”.</p> <p>And in addition, the Article 9(2) justification for processing special category data will be,</p> <p>Article 9(2)(d) “processing is carried out in the course of its legitimate activities with appropriate safeguards by a foundation, association or any other not-for-profit body with a political, philosophical, religious or trade union aim and on condition that the processing relates solely to the members or to former members of the body or to persons who have regular contact with it in connection with its purposes and that the personal data are not disclosed outside that body without the consent of the data subjects;”</p>

	<p>but occasionally on a case by case basis we may seek your explicit consent according to,</p> <p>Article 9(2)(a) “the data subject has given explicit consent to the processing of those personal data for one or more specified purposes, except where Union or Member State law provide that the prohibition referred to in paragraph 1 may not be lifted by the data subject”.</p>
5. Recipient or categories or recipients of shared data	<p>The data may be shared with:</p> <ul style="list-style-type: none"> • Derby & Derbyshire Integrated Care Board • Joined up Care Derbyshire • GPTF/The Hub Plus • GPPB • NHS England • GPC • BMA • Medical Defence Organisations • DCHS • DHU • Chesterfield Royal Hospital Foundation Trust • Derby teaching Hospital Foundation Trust • Derbyshire Healthcare NHS Foundation Trust • EMAS • Derbyshire County Council • Derby City Council • CQC • PHE • Other Health and Social Care providers and organisations as required
6. Right to object	<p>If Article 6(1)(c) or Article 9(2)(a) is being relied upon there is a right to object. If Article 6(1)(a) or Article 9(2)(a) is being relied upon you do not have to consent to your data being used by the LMC and you cannot object to the processing, but you can withdraw your consent at any time. You do not have to consent to your data being used by the LMC.</p>
7. Right to access and correction	<p>You have the right to access and be given copies of any of your identifiable data we hold or process, have any inaccuracies corrected, have processing restricted and to have an electronically portable copy of any information you have given us. You have the right to ask for your data to be deleted.</p>
8. Retention Period	<p>The data will be retained for as long as you are members plus 6 years to allow for tax follow on investigations. Practice contact record retention is detailed in our retention policy.</p>
